Things to always to keep *out of sight* in your vehicle

Purses	Spare Change
Cell Phones	Wallets
Laptops	Bank statements
GPS units	Credit cards
Jewelry	Checkbooks
iPods	CDs
Keys	Charging/Docking Stations

Removing everything out of view from the interior of your vehicle will help prevent you from becoming a car prowler victim. Criminals look for a vehicle that will guarantee some sort of reward, making the risk of committing the crime worthwhile.

## Be safe while out and about

With the great weather now upon us you may find yourself spending more time outside, walking or running in the parks. When you are out on a walk or a run always be aware of your surroundings—personal safety should always be on your mind. Here are some tips to keep your personal safety a priority.

**Go with a buddy.** Enjoy the outdoors with a friend. In the event of an accident or injury, one can always go for help.

**Carry a cell phone.** If you are going out on a walk make sure to bring a cell phone with you in case you need to summon help.

**The daylight is your friend.** Its better to walk or run during the day rather than in the dusk or darkness.

**Use all your senses.** Listen for suspicious noises. Don't wear headphones—they impair your ability to hear someone coming up behind you. If for any reason you sense an area to be unsafe, *leave*.

**Take what you need.** Always carry personal identification. If you have a medical condition, carry identification that describes your illness.

**Have someone waiting.** Always let someone know where you are going and when you plan on returning.

**Be easy to find.** Always used marked and authorized trails.
