A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF MILL CREEK, WASHINGTON, ADOPTING AN ANNEX-  
ATION POLICY.

---

WHEREAS, the City of Mill Creek was incorporated on  
September 30, 1983, and

WHEREAS, prior to its incorporation the development of  
land and building uses in the area was ordered and coordinated  
with reference to certain rezone contracts, and

WHEREAS, the City is desirous of maintaining similar  
standards as it expands, and

WHEREAS, the City is still in the process of developing  
the system for the delivery of services to the existing area,  
and

WHEREAS, on March 14, 1984, the Council directed the  
Planning Commission to study the issue of annexing new terri-  
tory, and

WHEREAS, on May 3, 1984, the Planning Commission held a  
public hearing to discuss an annexation policy at which members  
of the public were given an opportunity to present testimony on  
the policy, and

WHEREAS, on June 11, 1984, the Council considered the recommendation of the Planning Commission and decided to hold a public hearing, and

WHEREAS, on June 26, 1984 the Council held a public hearing at which members of the public were given an opportunity to present testimony on the policy before the Council, now, therefore,

THE CITY COUNCIL OF THE CITY OF MILL CREEK, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. It is the general policy of the City that the Council will not take final action on any petition for annexation of developed residential property for two years or of undeveloped property for six months from the date of this Resolution or until otherwise directed by the City Council.
